
A message from the Faculty Director


IIRP Faculty Grant Program

Through its faculty grant program, the IIRP supports creative and scholarly research activities in collaboration with communities and institutions across Europe, Africa, and the Middle East.

Funded by the Office of the Provost and the College with generous support from the Humanities Division, the Physical Sciences Division, the Social Sciences Division, and the Pritzker School of Molecular Engineering, this program offers seed funding for both short- and long-term projects led by University of Chicago faculty and their partners abroad.


Many of these projects have benefitted from matching funds from partners and several have led to major external funding opportunities for our faculty investigators.








Number of Applications vs. Projects Supported by Year **Including Total Amount Requested & Funded**



This year, the IIPR Steering Committee received fifty-nine projects, doubling the number submitted last year. As a result, the Steering Committee had to make some very difficult choices. Of the 59 projects only 27 projects were funded and no project was fully funded. And this in spite of the very high quality of the projects submitted. It is our hope that IIRP's financial sources will grow and allow us to finance a greater number of projects.

With demand continuing to outpace available funding, a major priority for the IIRP will be developing new revenue streams through philanthropy, joint-funding programs with strategic partners, and providing support for successful applications to domestic and international funding agencies (e.g., European Research Council, US federal and non-federal agencies, corporations, etc.).

IIRP Faculty Grant

COVID-19 Transmission, Testing, and Vaccination Dynamics within Migrant Worker Social Networks

"Funding for this pilot from the Research Institute at the Paris Center was instrumental in obtaining a \$350,000 NIH R21 award."

The pilot study supported data collection in Athens, Greece, of Bangladeshi migrant workers concerning their experiences with COVID-19 and COVID-19 prevention. The pilot aided in developing a team which is now ready to start the full study, which will have a greater impact, as resources can focus on the main study objectives as opposed to infrastructure development and training support.

This developmental research characterizes the social and transmission networks of migrant workers in Greece as part of pandemic preparedness, to mitigate ongoing and future coronavirus epidemics among vulnerable populations in diverse contexts. We aim to better understand COVID-19 prevention, testing, treatment, vaccination, seroprevalence and immunogenicity in order to address facilitators and barriers to COVID-19 prevention. Migrant workers comprise one of the foremost essential worker categories, are at increased risk of COVID-19 transmission and at the same time have some of the lowest rates of testing and vaccination. Understanding the potential transmission dynamics would help develop tailored interventions to limit the explosive transmission documented in the US and Europe. The study context and team are ideal for this proposal. Athens Greece is the entry point to the largest migrant population in the EU and Bangladeshi migrants are the second largest constituency. Although the target population is very specific, it represents an extremely important stream of global migration that connects two populous world regions, with salient epidemiological consequences for the entire globe.

New Directions in Fiction Studies

This two-year project aimed at developing the work of the International Society for Fiction and Fictionality Studies (ISFFS/SIRFF), which grew out of collaborations between the University of Chicago and the Université Sorbonne Nouvelle. The project places the IIRP at the heart of the Society's scholarly network.

Our project comprised several components and outcomes, including: a) a co-sponsored multidisciplinary study day; b) a co-edited volume completed with the support of the IIRP; and a four-day seminar on "Degrees of Fictionality" held at the University of Chicago Center in Paris.

This project will continue with a follow-up conference on the same topic as the June seminar. It will take place at Kwansei Gakuin University, Japan, in October 2024 (organized by Akihiro Kubo and co-sponsored by Kwansei Gakuin University and the ASIFF).

Generous support received from the IIRP, the Association for Studies in Fiction and Fictionality Studies (ASIFF), the FoReLLis research group at the University of Poitiers, and the Maison des sciences de l'homme et de la société at the University of Poitiers.

Building an International Multidisciplinary Network Towards Personalized Cancer Chronotherapy

This project aimed to activate and link research networks and set the groundwork for future international research projects funded by the National Institute of Health and other agencies on cancer chronotherapy. The project leaders will publish the workshop's proceedings and are currently planning a third workshop given the great success of the previous two. The project has fostered international research collaborations and pilot studies both at UChicago and other universities.

Tropical Marxism

This conference brought together a variety of junior and senior scholars across disciplines such as history, anthropology, philosophy, political theory, and law to examine how anti colonial actors, intellectuals, and movements in the Global South theorized Marxism anew.

By the end of the conference, new collaborations were already in the works. There is a tentative plan to organize a smaller workshop on Tropical Marxism with a narrower focus in the history of political thought, which may result in an edited volume. Julian Go and Kevin Pham began to plan a co-authored article on Marx in Vietnam and Vietnam in Marx.

"We [...] took advantage of a critical mass of scholars interested in the topic who are based in Paris universities, for both participants and audience. Several of our participants based in Paris [...] observed that the conference provided a forum for conversations that are rare in French universities [...]."

In December 2023, the IIRP and the Neubauer Collegium signed an MoU to strengthen their collaboration. Both institutions committed to working together on projects that could benefit from their respective expertise in Chicago and in Paris. Out of this partnership, a project on Reproductive Healthcare amongst several promising projects have started to take shape.

Grant **Research**

Reproductive Healthcare

Drs. Chor and Premkumar conducted both clinical and research site evaluations with multiple teams at Necker Enfants du Maladies Hospital (NEMH), Trousseau Hospital (TH), Port Royal Hospital (PRH), and Sorbonne University (SU). The work done was a strong first step towards building longstanding relationships with research and clinical facilities around Paris.

Moving forward, Drs. Chor and Premkumar have short- and long-term plans to expand this project. Within the next three years, they plan to: a) improve Chicago-Paris collaboratives for the provision of abortion care, b) improve Chicago-Paris collaboratives for fetal therapy, and c) coordinate conferences focused on the future of reproductive health, with particular attention to reproductive autonomy and parenting in the U.S. and European countries. Over the next five to ten years, they plan to establish an inter- and trans-continental think tank focused on multidisciplinary approaches to reproductive health.



After participating in the Tropical Marxism conference organized by Professor Jennifer Pitts (Political Science), Professor Cadet was unable to return to Haiti due to the state of emergency that was declared in Port-au-Prince. With support from the Center in Paris, IIRP, and the Pozen Center, Professor Cadet was able to remain in Paris and continue his research.

Funding from the Pozen Center supported at talk by Professor Cadet in Professor James Sparrow's course on Human Rights. Professor Cadet engaged College students on the current crisis in the larger context of the history of democracy in Haiti. He spoke both as a scholar of political philosophy and the history of democratic thought and practice in Haiti, and as a first-hand witness to the events of recent years that led to the March crisis, and the students responded with engagement and excellent questions.

On the academic outcomes of Jean Jacques's activities in Paris: "It has contributed to my textbook work and to policy reform efforts in the United States. Eventually, I expect that it will lead to an edited volume."



American Studies Program

Tocqueville Conference



Organized in partnership with the Karla Sherer Center for the Study of American Culture with generous funding support provided by Amy and Paul Carbone "New Perspectives on Constitution in the Era of Revolutions," held on May 16 and 17, 2024 and organized by Linda Garbaye, Hugo Toudic, and Bertrand Van Ruymbeke, brought together a multidisciplinary group of experts at an important moment for contemporary constitutional practice and interpretation and in an inspiring historical setting to discuss the shared origins, early impact, and lasting legacies of the first wave of constitution-writing at the end of the eighteenth century.

Meeting at the Château de Tocqueville in Normandy, where Alexis de Tocqueville completed the second part of Democracy in America and composed The Old Regime and the French Revolution, participants from the disciplines of history, political science, philosophy, literature, and law engaged in a series of compelling talks and conversations that helped establish a common set of priorities for future engagements and a template for future programs. The speakers, moderators, and audience ranged from PhD students to emeritus professors, and they converged in Normandy from universities across France (Aix-Marseille, Caen-Normandy, Paris Cité, Paris Nanterre, La Rochelle, Sorbonne, Toulon) and the United States (Boston University, UChicago, Notre Dame, Penn, Stanford, USC).

Coming in the fall of 2025 History and the Foundation of the Separation of Powers

Where did our modern ideas about the separation of political powers—the proper balance between legislative, executive, and judicial roles and responsibilities—come from? How were those ideas transformed into practice and how have those practices evolved over time? We propose to assemble a set of experts for an international, multidisciplinary, multisite event to address one of the key legal and political issues of our own time by reflecting on the philosophical foundations of modern ideas of separation of powers in eighteenth-century Europe, on the implementation of some of those ideas in revolutionary America, and on the contests and disputes that have arisen from the age of Montesquieu to the present. The conference will be organized in part by Allison Lacroix (Law School and History) and Will Howell (Political Science and Harris/Public Policy), will feature scholars of history, law, political science, and philosophy, and will include events at the Paris Center as well as in the vicinity of Montesquieu's estate near Bordeaux, where the French political philosopher first set the terms we have used and debated over the past three centuries.

Looking Ahead for Quantum

Quantum Physics Workshop and the public presentation of **Quantum Casino**

Recent years have seen accelerated progress in the development and use of quantum materials and systems for both fundamental science and nascent technologies. To maintain this momentum and foster interdisciplinary collaborations, a workshop open to the public will be held on November 20-23 at the Boyer Center in Paris. It will focus on uniting specialists from the Chicago and France but will also broadly involve others from Europe and North America.

Most of the invited participants are affiliated with the French CNRS, CEA, Argonne National Laboratory, the University of Chicago, universities across Western Europe, and the Chicago area. The CNRS is the institution highly represented among the guest speakers, emphasizing a strong partnership through this workshop and forging future collaborations. Quantum research is designated as a priority research area (PEPR) in the France 2030 plan, and the CNRS has been heading these efforts.

After the workshop, the Center will host a one-day public event to introduce quantum technologies through game play. The University of Chicago's STAGE Lab at the Pritzker School of Molecular

Engineering has created the Quantum Casino, a suite of interactive games that explore how cooperative and competitive game play can afford everyone a better understanding of quantum physics. Interactive experiences will be offered through a "Quantum Photo Booth", with entangled qubits provided through a collaboration with IBM.

We aim to make this workshop and public event a yearly activity, alternating between Paris and Chicago, to sustain long lasting exchanges of ideas and collaboration. We hope that the partnership with the Boyer Center and IIRP will be long-lived, both within the context of this workshop and for the many collaborations it will foster.
